The Oacoma Town Board met in regular session at 7:00 P.M. on September 19, 2022 in Meeting Room #2 at the Oacoma Community Center. Board members present were Gary Dominiack, President; Richard Kirkpatrick, Vice President; Kyle Fuchs; Roger Twamley; and Robin Hutmacher. Also present was Valerie Moore, Finance Officer. **MINUTES**

Motion by Twamley, second by Fuchs, to approve the minutes of the regular meeting on September 6, 2022.

**2023 APROPRIATIONS ORDINANCE NO. 2022-04**

The second reading was held for Ordinance No. 2022-04, Appropriations Ordinance for Fiscal Year 2023 for the Town of Oacoma. Motion by Kirkpatrick, second by Fuchs, to approve the second reading and adoption of Ordinance No. 2022-04. Voting aye: Dominiack, Kirkpatrick, Fuchs, Twamley and Hutmacher. Voting nay: none. **PERSONNEL**

Motion by Hutmacher, second by Kirkpatrick, to hire Weston Waugh as a full-time Utilities Technician at the rate of \$20.00 per hour effective October 3, 2022 with a \$1.25 increase upon successful completion of five required certification exams including four Class I exams and one Class II exam. Motion by Fuchs, second by Twamley, to waive Waugh's training period in relation to use of accrued vacation leave benefits. Motion carried.

**OTHER DISCUSSION**
